With 9 oppose, 6 support, and 0 abstain, the ASCC stance on measure 26 is OPPOSE. With 9 oppose, 5 support, and 1 abstain, the ASCC stance on measure 27 is OPPOSE.

### **State Measure 28 – Funding Art and Music Education**

- Insert the stances of support or opposition as follows into the provided space within the fourth Whereas:
  - SUPPORT for County Measure A (Providing Authority to Remove Sheriff)
  - o SUPPORT for Measure CC (Cerritos College \$425M Bond)
  - o SUPPORT for State Measure 1 (Reproductive Freedom)
  - OPPOSE for both State Measure 26 and 27 (Regarding Gambling)
  - SUPPORT for State Measure 30 (Wealth Tax, Air Pollution/Wildfire Prevention)
- Strike the third resolved: "Resolved: This resolution shall only be considered valid in all of its provisions once it has been approved in the same form by both the Cabinet and the Senate; and let it be further"

Seconded by Senator Roxas. No objections, motion passes.

Senator Dunomes moves to approve JR-2223–03, seconded by Senator Alamgir. No objections, motion passes.
