**MEMORANDUM OF UNDERSTANDING
BETWEEN THE CERRITOS COMMUNITY COLLEGE DISTRICT AND THE
CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CHAPTER 161**

DECEMBER 20, 2021

ARTICLE 6: HEALTH AND WELFARE BENEFITS

This Memorandum of Understanding (MOU) between the Cerritos Community College District and the California School Employees Association (CSEA) and its Chapter 161, is expressly made pursuant to the Educational Employment Relations Act. This MOU is intended to address the extension of Article 6 concerning the health and welfare benefits for 2022.

WHEREAS, District and CSEA are parties to a collective bargaining agreement which expired on June 30, 2021; and

WHEREAS, the parties sunshined their initial proposal and are starting negotiations on December 20, 2021 towards a new 2021-2024 collective bargaining agreement, and

WHEREAS, new CalPERS medical rates become effective January 1, 2022.

THEREFORE, the parties agree as follows:

1. The District agrees to extend the provisions of Article 6 in the 2018-2021 collective bargaining agreement for the 2022 calendar year.
2. The District agrees that it will pay any cost in excess of the District maximum contribution (\$23,500) for the medical plan chosen by the eligible Classified members through December 31, 2022.
3. The District agrees that it will reimburse unit members for any payroll deductions incurred for 2022 health benefit premiums in excess of the District maximum contribution (\$23,500) for the medical plan chosen by the eligible Classified members.

This MOU shall expire in full without precedent on December 31, 2022, unless shortened or revised by mutual written agreement of the parties.


This Agreement is non-precedential, will not bind the parties in any future action, whether under similar circumstances or not, and cannot be introduced in any grievance, arbitration, complaint, administrative or legal proceeding as evidence of past practice or intent of the parties or meaning or application of the collective bargaining agreement.
